## Translator of This Volume

DENNIS D. MARTIN studied medieval and early modern religious history at Wheaton College (Illinois) and the Universities of Waterloo (Ontario, Ph.D., 1982), Marburg and Tübingen. In addition, he has received Fulbright and National Endowment for the Humanities fellowships. He was assistant editor of The Brethren Encyclopedia (1983) and The Mennonite Encyclopedia, volume 5 (1990), and taught church history at the Associated Mennonite Biblical Seminaries (Elkhart, Ind.). Since 1991 he has taught historical theology and church history at Loyola University, Chicago. His interest in Carthusian history and spirituality began in graduate school as an outgrowth of studies in Cistercian and Benedictine spirituality and led to a book on late-medieval Carthusian life, Fifteenth-Century Carthusian Reform (E. J. Brill, 1992). He is presently working on a study of royal and noble patronage of Carthusian monasteries in Austria, Styria, England, France, Aragon and the Holy Roman Empire during the twelfth to fourteenth centuries as well as on a general history of the Carthusian Order through the centuries.

JOHN VAN ENGEN is director of the Medieval Institute and professor of history at the University of Notre Dame. He is a specialist in the religious and intellectual history of the European Middle Ages. His first book, Rupert of Deutz (1983), treated the twelfth-century Benedictine author.
