THE CARTAE CARTUSIANAE (Brussels Royal Library MS II 1959)

HANS DE JONG

This short article contains a summary of my investigation into the Carthusian Cartae (MS Brussels Royal Library II 1959). This manuscript, originating from the Carthusian house of Herne, near Brussels, contains the Cartae of the General Chapter of the Carthusians for 1416-1426 and 1428-1442.

This article will be divided in two parts. First, I shall discuss the manuscript itself. After that, I shall offer a description of the manuscript according to the method discussed by A. Gruys and A. Geurts in their book Codicografie en Computer 2 with an appendix.

The Brussels manuscript contains the only remaining Cartae of the northern province of Picardy. In the Nether-

lands, the Cartae have been lost for many reasons. In the Northern provinces (the present day Holland), the suppression of the Carthusian houses was effected by the Reformation. In present day Belgium, the Carthusian houses were dissolved by the Emperor Joseph II of Austria in 1783. He did not destroy the archives of the monasteries. Many charterhouses tried to conceal their archives. The Carthusians sometimes took archival documents with them. Probably, this also happened to our manuscript. The Royal Library acquired it in 1897.

The Cartae of the Carthusian house of Herne have a clear structure. They begin with the notices of deaths of the members and the benefactors of the male as well as the female branches of the order during the past year. At the same time, they mention the obligatory prayers to be executed for the dead. The following distinctions are made:

- a) Tricenarium: 30 Holy Masses for the benefit of a deceased person.
- b) Anniversarium: Annual Mass on the anniversary of a person's death.

- c) Monachatus plenus: Two Psalters, recited by every Carthusian for the benefit of a deceased fellow-brother.
- d) Monachatus simplex: An anniversarium and a tricenarium.
- e) Monachatus plenus per totum ordinem: Two psalters and two Holy Masses.

These prayers had to be fulfilled either by the whole order or by a single province. Because of this, these lists are very interesting to compilers of prosopographies. Yet they cannot be considered "obituaria" or "necrologia". A "necrologium" or "obituarium" is ordered according to the Roman Calendar. The deceased of the Cartae are ordered according to the group to which they belong (Benefactors, monks, lay brothers, nuns, lay sisters). It is true that these lists have been used as a source for an "obituarium" or "necrologium". The general intentions of prayer follow after the notices of deaths. The monks recited their prayers for the benefit of the Catholic sovereigns and the unity of the Church, which was afflicted by the Western Schism. Furthermore, the decisions of the General

Chapter, which referred to the whole order, were listed.

Then the dispositions which referred to the northern province of Picardy, of which the Carthusian house of Herne was one, 5 followed. Eventually, the dispositions which referred to the monasteries of the adjacent provinces (England, "Picardy Propinquor" and the Rhine province) with the arrangements for visitations, were indicated.

This manuscript is not primarily of codicological interest. We only know two codicological descriptions. These descriptions ignore the discrepancies between the quires. These differences bear on the method of ruling, the watermarks, the collation and the hands. The differences between the quires can be explained from the origin of this archival convolute. Every quire corresponds to one Carta. The quires were written independently of each other. Later, they were brought together. Lamalle holds that the Cartae were bound very early. He refers to the golden stamps on the spine of the binding, which are, in his opinion, typical for the fifteenth century Carthusian

house of Herne. There are, however, arguments to date the binding later. On the second inter-band space a gold stamped title can be seen. This is a custom, which came into use in the seventeenth century. Lamalle's second argument relates to the contents. Lamalle refers to the fact that A. Beeltsens, the fifteenth century chronicler of the Carthusian house of Herne, who died in 1490, did not use any date of the Cartae outside the period 1416-1426, 1428-1442.

There is no decoration. It is noteworthy that most quires written before 1430 have been executed by one single hand. After that year, every quire was written by several hands. In the appendix to the description, I have distinguished the changing of hands precisely. Mostly, a monk copied one or two pages after which another took over. It is remarkable that the hands differ strongly from each other. This could be an indication that the Carthusians of Herne did not develop their own way of writing, but every monk retained his writingstyle, which he had learned elsewhere. This would agree with J.P. Gumbert's conclusions with regard to the Carthusian house of Nieuwlicht. On After

1430 the lay out of the notices of deaths changed, too. Every group within this list received its own paragraph, whereas before 1431 the difference between the groups was not expressed by means of the lay-out.

A closer study of the quires yields interesting information, too. On 54v the following annotation occurs: "Hic carta mittatur ad domum Montis sancti Ludovici". This Carthusian house was situated in Valenciennes and was the mother-convent of Herne. The Carthusian house of Herne was founded by Carthusians from Valenciennes. The Carthusian house of Valenciennes, however, belonged to the province of "Picardy Propinquor", while the Carthusian house of Herne was a part of "Picardy remotior".

The description of the manuscript is in accordance with the scheme proposed by A. Geurts and A. Gruys. This model departs from a number of codicological basic conventions. It is necessary to give some explanation of these elements. The heading begins with a code of the country, which conserves the manuscript. This code has been derived from the international code of motor-vehicles. The date indicates the period in which the manuscript was written. The Arabic numerals refer to the century, the letters "a" and "b" to the first and second quarter of the century. has been adopted. According to this code, the Roman numeral III means a juridical, the Roman symbol IV an administrative source. To describe the differences between the quires, I have compiled an appendix in which we describe every quire separately. The format, the way of ruling, the collation and some remarks about the quire are recorded. The collation follows the method of N.R. $\operatorname{Ker.}^{12}$ A Stevenson Scheme to indicate the place of the watermarks within a quire concludes our study. The letter "W" means that there is a watermark on that folio, while the letter "O" signifies that there is no watermark. From this Stevenson-Scheme, it appeared that some quires have several watermarks, whereas others have none. Where possible, Piccard and Briquet numbers 13 of every watermark have been noted in the appendix to the description. It appears that a quire is composed of double-folios which had not relation to each other. They were formed into a quire by the copyists of the Cartae.

See appendix. The missing folios disappeared before the manuscript was foliated. The stubs are visible. There are sometimes traces of ruling on them. The folios have been cut out.

Watermark:

head of an ox, anchor, paschal lamb, flower de luce, basilisk, Letter T, 2 keys, crown, monogram. The diversity is caused by the composition of the manuscript, which consists of quires which were formed independently of each other.

Catch words:

47 v., 109 v (quire catch word), 113 r., 114 r.

Mise-en-page:

one column, a margin of 2 $\,\mathrm{cm}$. on the left hand side. For further information, see the appendix.

Method of ruling:

blind, only for the text space. Some quires have not been ruled.

Prickings:

If they are present, they are to be found in the left margin of the recto-side of the folio. They corresponded to the paragraphs of the text. Probably, each folio was ruled separately. From quire 22 onwards, there are prickings or instructions to place prickings on the first three folios of every quire.

WRITING

Mainly gothic cursiva currens. From quire 15 on, there are several hands for every quire. Sometimes a cursiva formata or a littera hybrida is found.

Corrections:

erasure (121 v.), correction in the margin (63 v.), later correction by erasure and rectification at the bottom of the page (32 v.), erasure and correction just above the erasure (152 r.)

Rubrication:

none. The indications of the different paragraphs have mostly been done by the same hand with the same ink as the text. The letter type of the heading sometimes deviates from the text. This happened on 149 r. (textualis), 167 v. (textualis), 178 r. (textualis), 138 r. (littera hybrida) Abbreviations:

This manuscript is characterized by numerous abbreviations. Other signs:

BINDING

s. 17-18, cardboard cloth covered with calf leather. The boards are not decorated. The spine is decorated with golden stamps (lozenges) on the third, fourth, fifth and sixth interband space. The signature has been indicated on the first inter-band space by a label. The title has been indicated on the second inter-band space by a golden stamped mark: Carta Cap. gnl. 1416. The spine is now loose. The binding has not been restored. The pastedowns form a double folio with the fly-leaves. The first pastedown has come loose, too. At the second and first band, the binding band is missing.

On the recto-side of the first fly-leaf, is the notice:
"Cartusiae Capellae". Thoroughout the manuscript are
red stamps "Bibliothèque Royal" and some more recent
blue stamps of "Bibliotheca Belgica". During the period
1982-1983, there were discussions about a transfer of the
manuscript to the State Archiv of Brussels.

Acquisition:

This manuscript originates from the Carthusian house of Herne, which was dissolved by Joseph II in 1783. Nothing is known about the fortunes of the manuscript during the nineteenth century, until the Royal Library bought this manuscript from A.C. de Vyt, bookseller at Ghent, for the price of 88 francs.

A MANUSCRIPT OF HEINRICH REICHER'S DE DIVINA SAPIENTIA JAMES HOGG

On Monday morning, 21 May 1984, the antiquarian bookseller F. Dörling, Neuer Wall 40-42, D 2000 Hamburg 36, auctioned a Carthusian manuscript of south German provenance dated 1450, containing the *De Divina Sapientia* of the Würzburg Carthusian Heinrich Reicher of the charterhouse *Horti Angelorum*. Little is known of the author¹, who may well have been a compiler rather than a spiritual writer in his own right.² Unfortunately, neither the seller nor the buyer of the manuscript could be ascertained³, and thus its present whereabouts are unknown.

The manuscript, no. 3787 in Dörling's catalogue⁴, was described as follows:
